

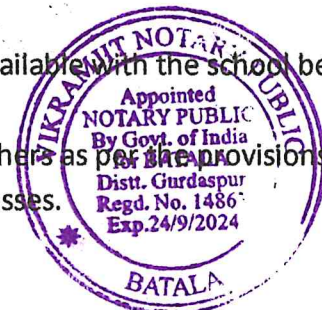

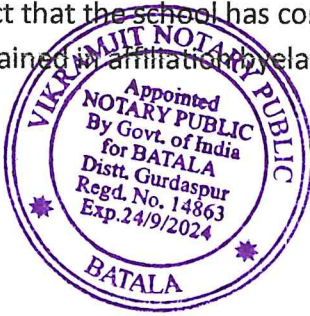
AFFIDAVIT

7. That the Principal and Corresponding/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of land.
8. That the school will ensure that all the required infrastructure is available with the school before starting classes.
9. That the school will ensure that all the required infrastructure is available with the school before starting classes.
10. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

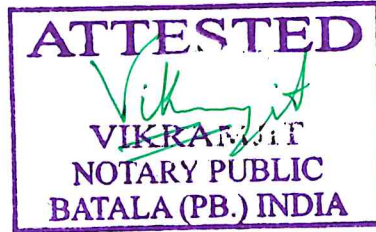


11. That the school will ensure sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
